Textual Information()	<p>Mr. Vaibhav Agarwal (a shareholder belonging to Promoter / Promoter Group) was holding 5,24,000 Equity Shares of the Company as on 31st March, 2020. The Company had received a letter dated- 10/07/2020 from Mr. Vaibhav Agarwal stating that Narnolia Financial Advisors Limited (One of the SEBI Registered 'Depository Participant') where he is holding demat account and in which the above shares was lying in demat mode, had informed him vide their letter dated- 10/07/2020 that they had inadvertently sold 154 Equity Shares of the Company out of total shares hold by him on 26th June, 2020 in the open market without any request/instruction from his side and without his knowledge. Thus, his total holding of Equity Shares in the Company reduced to 5,23,846 Equity Shares. The Company had again received a letter dated- 14/09/2020 from Mr. Vaibhav Agarwal stating that in order to maintain his holdings at an earlier level since he belongs to Promoter Group category, he had again purchase 154 Equity Shares of the Company on 02/09/2020. It is to be noted that the relevant shares i.e. 154 Equity Shares forms only 0.0003 % of total equity share capital of the Company and total transaction value of sold shares was Rs. 3,168 (Rupees Three Thousand One Hundred and Sixty Eight only).</p>
